TERMS AND CONDITIONS FOR DONATION PAYMENTS

Preamble

By publishing these Terms and Conditions, GRCS shares information about its data collection and data usage policies while accepting donations online.

These Terms and Conditions are applicable to all physical and legal persons (hereinafter referred to as "**Donor**") who donate to the **Georgia Red Cross Society (ID: 202051536)** (hereinafter referred to as "**GRCS**") either through its official website (<u>https://redcross.ge/en/donate</u>) or via other related digital fundraising platform.

1. Information We Collect & the Purposes of Usage

- 1.1. The information we may collect includes information you provide to us directly, as well as automatically generated information through your use of our website. This information enables us to improve our work, communicate with you about our programs, respond to your inquiries and provide support, fulfill your requests and donations, and for other donor service purposes. We also use information to improve our understanding of your interests and better tailor the content and information that we may send or display to you, such as newsletters or other information we think may interest you.
- 1.2. By making a donation on GRCS web page, and\or on other related digital platforms you provide us with certain personal data (First Name, Last Name, Date of Birth, contact info: email address etc.), which will be used by the GRCS to proceed with your donation. Please make sure that the provided information is accurate and up to date.
- 1.3. We may send periodic promotional or informational emails to you. You may optout of such communications by unsubscribing or contacting us directly via our official email.

2. Donor Rights and Obligations

- 2.1. There are no other rights arising for a donor out of the donation other then the right to be assured that the donation has gone for humanitarian purposes.
- 2.2. You are able and encouraged to donate on behalf of other persons as well.
- 2.3. In case of natural persons, one must be of legal age in the country from which the donation is made.
- 2.4. Donors should own the funds themselves and should have the full legal right to control it as they see fit.

3. Data Protection

- 3.1. These Terms and Conditions apply separately to each donation that a donor makes.
- 3.2. Personal data provided by you will be handled according to the Georgian Law on "Personal Data Protection". Your personal data will not be shared to any third parties unless it is directly required by the abovementioned law. In particular, the GRCS may disclose the information collected from you when it is necessary to investigate, prevent, or take action against illegal activities, suspected fraud, situations involving potential threats to the safety of any person, violations of our Terms and Conditions.

- 3.3. The GRCS takes the responsibility to observe confidentiality regarding the data that is viewed by its representatives while processing the donation subject to exceptions which are prescribed by the **Georgian law on Personal Data Protection**
- 3.4. We may automatically collect the following information about your use of our website through cookies, web beacons, and other technologies: your domain name; your browser type and operating system; web pages you view; links you click; your IP address; the length of time and number of times you visit our site and or use our services; and the referring URL, or the webpage that led you to our site, and the following: access time, browser type, device ID, domain name, IP address, page views, pages visited and referring URL.

4. The Use of Funds

4.1. The funds collected through online donations will be entirely devoted to the GRCS's humanitarian relief operations and used fully in accordance with the Statutes of the Georgia Red Cross Society.

5. General Provisions

- 5.1. GRCS reserves the right to make changes into these Terms and Conditions from time to time, so please be sure to check it consistently before making each donation.
